### CHATHAM HOUSE DEBATES 'A BOLD BRITAIN: REMAKING A MAJOR EUROPEAN POWER' WITH CHUKA UMUNNA

The foreign policy think tank Chatham House is to hold a debate on 'A bold Britain: Remaking a major European power' with Chuka Umunna MP, Chair of Vote Leave Watch who will address questions such as what role Britain should play in both Europe and the wider world, and how the UK can meet its obligations in shaping a more social and democratic global order while still upholding its national interests.

#### EU GENERAL AFFAIRS COUNCIL HOLDS ARTICLE 50 MEETING – LUXEMBOURG

Ministers from the EU 27 will prepare the European Council (Art. 50) of 29 April (see separate story) by examining the draft guidelines for the Brexit negotiations. The guidelines, to be adopted by the European Council, will define the framework for negotiations with the UK and will set out the overall EU positions and principles. This will be the first step of the Brexit process following the UK notification to the European Council of its intention to leave the EU on 29 March 2017.

#### INSTITUTE FOR GOVERNMENT DEBATES THE CREATION OF BRITAIN'S NEW TRADE DEPARTMENT

The Institute for Government will hold a keynote speech by Sir Martin Donnelly at 18:00 to discuss the creation of Britain's new trade department, and how best to organise and run a modern civil service. The discussion will be chaired by Bronwen Maddox, Director of the Institute for Government. Sir Martin Donnelly was Permanent Secretary at the



Department for International Trade (DIT) until leaving the civil service on 24 March 2017. Previously, he was Permanent Secretary at the Department for Business, Innovation and Skills (BIS).

#### POLICY EXCHANGE DEBATES 'BURN OUT: THE ENDGAME FOR FOSSIL FUELS'

China's great economic expansion, which caused so much of the latest commodity super-cycle, is slowing. Low oil prices are sending shockwaves through the global economy. Recent surges in technological innovations, from the internet of things and improvements in battery technologies, to the coming of robots and artificial intelligence, will bring about an energy revolution which could involve the electrification of almost everything. This will inexorably reduce the demand for oil and gas, and prove more effective than current efforts to avert climate change. These are just some of the trends shaping our energy and climate future illuminated in Professor Dieter Helm's new book, 'Burn Out: the endgame for fossil fuels', which will be launched at Policy Exchange today.
